

## Privacy Notice

The SIPS study is using routinely collected NHS data (routine data) to meet a number of its key objectives. This routine data will allow the study team at the University of Bristol to describe the patient characteristics of those who are admitted to hospital with a severe, full skin thickness pressure ulcer. It will also enable the study team to compare outcomes for groups of similar patients who do and do not have surgical reconstruction following their admission to hospital with a severe, full skin thickness pressure ulcer. Surgical reconstruction of pressure ulcers is not common in the United Kingdom, and at the moment it is not clear which patients with pressure ulcers may benefit from an operation and which of the different ways of doing surgery is best. The SIPS study aims to find out more about how best to conduct research in this area.

NHS Digital, who are the holders of routine data in England, will be asked to create a cohort of patients who are known to have been admitted to hospital with a severe pressure ulcer from 2011-2019. NHS Digital will then provide the study team at the University of Bristol with pseudonymised information on these patients relating to outpatient visits, hospital admissions and deaths. In pseudonymisation, something in the data which identifies an individual is replaced with an artificial identifier, for example a reference number. At no point will identifiable information be provided to NHS Digital by the University of Bristol, or by NHS Digital to the University of Bristol. No attempt will be made to identify anyone from this data. The transfer of data will be secure and only necessary data will be transferred. Data will be stored on secure University of Bristol managed servers for 5 years from the end of the study, as is required in clinical trials. This period will be from October 2021 to October 2026. These processes will be overseen by three joint Data Controllers – the University of Bristol, the University of Manchester and Manchester University NHS Foundation Trust.
