Timeline of Scholarship Process – Stelios Scholarship

- Applications accepted on a rolling basis
- Applicants are strongly encouraged to submit their application by mid-February 2018
- First selection round will take place in late February, with decisions announced by late March
- Shortlisted applicants may be contacted for an interview or to supply further information
- Successful applicants need to return acceptance form by certain date

Timeline of Scholarship Process – all other scholarships*

- Submit application online by 5pm BST on 8th May 2018
- Applications processed and sent to awarding panel. Only the scholarship application form is sent – they do not have access to your transcript or CV
- Awarding panels make decisions throughout summer, normally from June until mid-August. Some may contact shortlisted applicants for further information
- All applicants informed of decision on each scholarship as and when it is made
- Successful applicants need to return acceptance form by a set date

Course Scholarships

- Dozens of course scholarships awarded in recognition of previous outstanding academic achievements and a strong course application.
- Open to all applicants on full-time courses on the MSc Programme.
- **No need to apply for the course scholarship as it is awarded by the Admissions Panel and the candidates are shortlisted from the overall pool of successful applicants.** The majority of course scholarships are awarded at the time the course offer is made, and while funds are still available.
- Up to 20% of the tuition fees, and takes the form of a discount deducted from the second instalment of the tuition fees in January.





Loans

PG Government Loan (UK and EU students, restrictions apply)

- Up to £10,000
- Non-means tested
- Paid directly to student in three equal instalments

Professional and Career Development Loan (British citizens)

- Between £300 and £10,000

Future Finance (UK and EU citizens, and Non-EU citizens with UK guarantor)

- Between £2,500 and £40,000





Terms and Conditions of Scholarships

- Please be informed that it is Cass MSc Admissions policy that only one Cass scholarship/course scholarship/discount can be offered to each applicant. Should you be awarded any other scholarship/discount or be fully funded by an outside source (with the exception of a repayable bank loan) you would have to make a choice of which award you would like to accept.
- All scholarships and discounts are credited towards the second instalment of tuition fees; students are therefore expected to pay the whole of the first instalment (or the remaining fees if the award is larger than half the tuition fees) during online registration.
- Full details of the terms and conditions of accepting a scholarship will be provided with the award confirmation letter.
